Students will execute all training objectives and all shooting will be from a concealed carry holster. Students build on this training progressively and add lifesaving personal defense skills to their training. This class is taught as an intense immersive course yet completely appropriate for husbands & wives, females, & college students to take and build important critical self defense strategies and mind sets for surviving a violent attack at home, on the streets, at the office, or a public place.

Course Topics:

Developing a survival mindset and working with the Body Alarm Response.

Defense Tactics using just hands and or edged weapons that focus on:

- Securing personal space, countering an attack, and positional awareness
- surviving close quarter & multiple attacks
- the use of improvised defensive weapons
- bridging / getting to weapon deployment
- defending against / using various edged weapon types

Close quarter shooting:

- fundamental firing at speed & adding weapon retention
- engaging from weapon retention positions
- engaging multiple threats while seated
- engaging during movement
- reloading on the move;
- engaging in multiple directions at multiple threats on the move
- drawing & firing under physical threat
- drawing & firing when pinned and/or controlling the threat
- transitions and empty weapon use
