## **2-MAN TACTICS**

### **PATROL AND FIRST RESPONDERS**

#### **Course Description:**

The most common sized element in the field and on the streets in Law Enforcement is the Two Man Team. This course is essential for Patrol Officers and First Responders who maybe responding to a Dynamic Scene without immediate backup available. In today's world; the real world, this is an important course for Law Enforcement Officers, small military units, and even private industry protection professionals to take in preparation for an aggressive response to a Dynamic Lethal Situation (Active Shooter, Violent Offenders, Domestic Responses, etc..). In the field and on the streets; when violence occurs, more and more officers are being met with greater levels of violence and criminals with training and rehearsed tactics. Officer safety demands greater training in these areas and the officers in the field need the confidence to make the decisions they need to in order to protect the public and neutralize the threats before them. With special thought and tactics incorporated into the training regiment this small team can be maximized into a very efficient and effective team and officer safety is greatly increased.

Using realistic training scenarios this course is demanding and fast paced. Through the use of innovative simulation and live fire-drills, we prepare two man teams to operate in unison and to quickly and safely locate, close on, and neutralize a serious threat. Student drills initiate from the moment a call is received to on-scene assessment, response and final conclusion to contact. This will be an intense and physical class. It will be reality based with induced stress; all students walk away with some solid lessons learned, great training under their belt, and increased confidence needed for response to Dynamic Lethal Situation.

This course is designed primarily for active Law Enforcement or Military personnel – priority is given to Law Enforcement & Military enrollments. Law Enforcement Officers and their partners are encouraged to take this course together to maximize the learning objectives and to further develop the critical team functions.
